Explanatory Note

The main purpose of this Order is to amend section 5 of, and the Schedule to, the Protection of Endangered Species of Animals and Plants (Exemption for Appendices II and III Species) Order (Cap. 586 sub. leg. B) (*principal Order*) to give effect to the changes made in March 2013 to the resolutions adopted by the Conference of the Parties to the Convention on International Trade in Endangered Species of Wild Fauna and Flora.

2. This Order also makes minor textual amendments to the principal Order.
