

FORESHORE AND SEA-BED (RECLAMATIONS) ORDINANCE (Chapter 127)

Notice of authorization under section 9

**PROPOSED ASIA PACIFIC GATEWAY
FROM TSEUNG KWAN O TO THE EASTERN BOUNDARY
OF THE HONG KONG SPECIAL ADMINISTRATIVE REGION WATERS**

It is hereby notified that the undertaking in relation to the foreshore and sea-bed described in the Schedule below as mentioned in G.N. 2710 published under section 5 on 9 May 2014 and 16 May 2014 was authorized under section 7 by the Chief Executive on 29 July 2014.

Any person who considers that he has an interest, right or easement in or over such foreshore and sea-bed that will be injuriously affected by the undertaking may deliver a written claim for compensation for the injurious affection to the Director of Lands, 20th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong before the expiration of 1 year from the date of publication of this notice in the *Gazette*, stating the sum of money which he is willing to accept in full and final settlement of his claim together with such particulars as he may possess to substantiate the claim.

SCHEDULE

Foreshore and sea-bed affected

Approximately 1.75 hectares of foreshore and sea-bed situated from Tseung Kwan O to the eastern boundary of the Hong Kong Special Administrative Region waters as delineated and shown as a bold red line on a plan, numbered SKM8520a, deposited in the Land Registry.

Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking

- (i) Installation of an optical fibre submarine cable of approximately 35 kilometres in length and 100 millimetres in diameter by divers and jet technique, buried in a trench of approximately 0.5 metre in width at a depth of approximately 5 metres below the sea-bed.
- (ii) Where the submarine cable crosses a sewage pipe of Drainage Services Department and a gas pipeline of Hongkong Electric Company Limited, it will be surface laid and shallow buried for a distance of approximately 100 metres and 200 metres respectively at the crossing point. The surface laid section of the submarine cable will be protected by Uraduct or other similar protection. The existing sea-bed level will not be altered.
