

## RAILWAYS ORDINANCE (Chapter 519)

## SOUTH ISLAND LINE (EAST)

AMENDMENT TO CREATION OF RIGHTS OF  
TEMPORARY OCCUPATION OF LAND

TAKE NOTICE that under powers delegated by the Chief Executive, the Deputy Director of Lands/Specialist has made an order ('the Order') under section 20(1) of the Railways Ordinance (Chapter 519) (hereinafter referred to as 'the Ordinance') and section 46 of the Interpretation and General Clauses Ordinance (Chapter 1) directing that the rights of temporary occupation of land created by the order referred to in Government Notice No. 3531 dated 2 June 2011 (hereinafter referred to as 'the Original Order') be amended to the effect that in relation to the land more particularly described in the first column below as shown coloured purple stippled black on the Amendment to Creation of Rights of Temporary Occupation of Land Plan No. RDM1311a annexed to the Order (hereinafter referred to as 'the Plan') which land was described in the scheme referred to in Government Notice No. 4569 published on 24 July 2009 and 31 July 2009, and as amended by Government Notice No. 3204 published on 4 June 2010 and 11 June 2010 and was authorized by the Chief Executive in Council and such authorization was gazetted in Government Notice No. 7668 published on 10 December 2010 and 17 December 2010, and further amended by Government Notice No. 3183 published on 11 May 2012 and 18 May 2012 and such amendments were authorized by the Secretary for Transport and Housing and such authorization was gazetted in Government Notice No. 5180 published on 3 August 2012 and 17 August 2012, the period during which rights of temporary occupation of land have been created shall be amended as described in the second column below:—

<i>Description of Land</i>	<i>Amended Period during which Rights of Temporary Occupation of Land are to be Created</i>
Portions of the Remaining Portion of Ap Lei Chau Inland Lot No. 133 (formerly known as Portions of Ap Lei Chau Inland Lot No. 133) (Between the level of 34.8 metres above Principal Datum of Hong Kong (which expression shall have the same meaning as in the First Schedule to the Interpretation and General Clauses Ordinance (Chapter 1) and is hereinafter referred to as 'P.D.') and the level of 80.0 metres above P.D.; and Between the level of 34.8 metres above P.D. and the level of 68.0 metres above P.D. (excluding existing structures of footbridge))	From 3 September 2011 to 30 September 2016 instead of from 3 September 2011 to 30 June 2015

The Deputy Director of Lands/Specialist has under section 20(3) of the Ordinance further directed that subject to the serving of any notice required to be given under section 20(5) of the Ordinance, Government officers, any persons authorized by the Government and his or their workmen, servants, agents and contractors are authorized to enter upon the said land and the buildings thereon for the purposes of carrying out any operations or installing, maintaining or removing any structures or apparatus for the purposes of the Original Order and the Order.
