INSPECTION OF THE 2016 FINAL REGISTERS

Pursuant to section 38 of the Electoral Affairs Commission (Registration) (Electors for Legislative Council Functional Constituencies) (Voters for Election Committee Subsectors) (Members of Election Committee) Regulation (Cap. 541B), it is hereby notified that a copy of the functional constituencies final register and a copy of the subsector final register are now available for public inspection from 16 July 2016 onwards during ordinary business hours from Monday to Friday (other than a general holiday) at the following places –

- (a) Registration and Electoral Office: 10th Floor, Harbour Centre, 25 Harbour Road, Wan Chai, Hong Kong;
- (b) Registration and Electoral Office: 13th Floor, Kowloonbay International Trade and Exhibition Centre, 1 Trademart Drive, Kowloon Bay, Kowloon;
- (c) Central and Western District Office: Public Enquiry Service Centre, Ground Floor, Harbour Building, 38 Pier Road, Central, Hong Kong;
- (d) Yau Tsim Mong District Office: Public Enquiry Service Centre, Ground Floor, Mong Kok Government Offices, 30 Luen Wan Street, Mong Kok, Kowloon;
- (e) Kwun Tong District Office: Public Enquiry Service Centre, Ground Floor, The Grande Building, 398 Kwun Tong Road, Kwun Tong, Kowloon;
- (f) Tsuen Wan District Office: Public Enquiry Service Centre, 1st Floor, Tsuen Wan Multi-storey Carpark Building, 174-208 Castle Peak Road, Tsuen Wan, New Territories; and
- (g) Sha Tin District Office: Public Enquiry Service Centre, Ground Floor, Sha Tin Government Offices, 1 Sheung Wo Che Road, Sha Tin, New Territories.

The date of 16 July 2016 (Saturday) is not an ordinary business day of the Electoral Registration Officer. However, as that day is the first day of the nomination period for the 2016 Legislative Council General Election, the office of the Electoral Registration Officer (as set out in items (a) and (b) above) will make special arrangement for opening from 9:00 am to 12:00 noon on that day to make the functional constituencies final register and subsectors final register available for public inspection.
