TAKE NOTICE that under powers delegated by the Chief Executive of the Hong Kong Special Administrative Region, the Deputy Director/Specialist, Lands Department has made an order under section 13(1) of the Roads (Works, Use and Compensation) Ordinance (hereinafter referred to as 'the Ordinance') directing that:—

- (i) all those pieces or parcels of land in Yuen Long, New Territories known and registered in the Land Registry as:—
 - Lots Nos. 26 RP (Portion), 27 RP (Portion) and 28 RP (Portion) all in Demarcation District No. 101;
 - Lots Nos. 3250 S.B ss. 23 RP (Portion), 3250 S.B ss. 33 RP (Portion) and 3719 S.F RP [formerly known as 3719 S.F RP (Portion)] all in Demarcation District No. 104;

YLM 7018d and DNM 2109b annexed to the said order, which land was described in the scheme referred to in Government Notice No. 3720 published on 6 June 2008 and 13 June 2008 and as amended by Government Notice No. 2600 published on 30 April 2009 and 8 May 2009 and as modified by Government Notice No. 211 published on 15 January 2010 and 22 January 2010 and as further amended by Government Notice No. 5492 published on 26 September 2014 and 3 October 2014, shall be resumed.

Any person entitled to compensation under the Ordinance may serve a written claim upon the Secretary for Transport and Housing at 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong before the expiration of one year from the date of resumption.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Secretary for Transport and Housing in connection with any written claims served under section 29 of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) will be used for the processing of the claims and other related purposes. The provision of the information, including the personal data, as required under section 29 of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is obligatory. If such information, including the personal data, as required under section 29 of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is not provided as requested, the claims may be rejected. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other organizations or agencies which are required to handle the claims and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data in relation to their claims. Request for access to or correction of the personal data should be made in writing to the Personal Data Privacy Officer of the Transport and Housing Bureau (Transport Branch) at 20th Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong.
