FIRST STAGE OF DESALINATION PLANT AT TSEUNG KWAN O**

It is hereby notified that the undertaking in relation to the foreshore and sea-bed described in the Schedule below was authorized under section 8(1)(c) by the Chief Executive in Council on 14 March 2017.

Any person who considers that he has an interest, right or easement in or over such foreshore and sea-bed that will be injuriously affected by the undertaking may deliver a written claim for compensation for the injurious affection to the Director of Lands, 20th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong before the expiration of 1 year from the date of publication of this notice in the Gazette, stating the sum of money which he is willing to accept in full and final settlement of his claim together with such particulars as he may possess to substantiate the claim.

SCHEDULE

Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking

Foreshore and sea-bed affected

Approximately 2.24 hectares of foreshore and sea-bed situated at Joss House Bay as delineated and shown edged red on a plan, numbered SKM9000, deposited in the Land Registry.

The proposed works include:—

- (i) Construction of the submarine intake pipeline of about 250 metres in length and submarine outfall pipeline of about 350 metres in length by trenchless construction method;
- (ii) Construction of the intake structure and the outfall diffusers (dredging of sea-bed is required); and
- (iii) Erection of a temporary works area at the end sections of the submarine intake and outfall pipelines to facilitate the construction of the intake structure and outfall diffusers.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Director of Lands in connection with any written claims served under section 12(1) of the Foreshore and Sea-bed (Reclamations) Ordinance (Chapter 127) will be used for the processing of the claims and other related purposes. The provision of the information, including the personal data, as required under section 12(1) of the Foreshore and Sea-bed (Reclamations) Ordinance (Chapter 127) is obligatory. If such information, including the personal data, as required under section 12(1) of the Foreshore and Sea-bed (Reclamations) Ordinance (Chapter 127) is not provided as requested, the claims may be rejected. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other organizations or agencies which are required to handle the claims and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us.
