

## FORESHORE AND SEA-BED (RECLAMATIONS) ORDINANCE (Chapter 127)

RUNWAY AND SOUTH APRON  
CONSTRUCTION OF WATERFRONT PROMENADE AND SEAWATER INTAKE  
POINT AT FORMER KAI TAK RUNWAY

It is hereby notified that the undertaking in relation to the foreshore and sea-bed described in the Schedule below as mentioned in G.N. 9601 published under section 5 on 15 December 2017 and 22 December 2017 was authorized under section 7 on 9 March 2018.

Any person who considers that he has an interest, right or easement in or over such foreshore and sea-bed that will be injuriously affected by the undertaking may deliver a written claim for compensation for the injurious affection to the Director of Lands, 20th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong before the expiration of 1 year from the date of publication of this notice in the Gazette, stating the sum of money which he is willing to accept in full and final settlement of his claim together with such particulars as he may possess to substantiate the claim.

## SCHEDULE

### *Foreshore and sea-bed affected*

Approximately 9 650 square metres of foreshore and sea-bed situated at the Kai Tak Approach Channel and approximately 750 square metres of foreshore and sea-bed situated at the To Kwa Wan Typhoon Shelter as delineated and shown edged red on a plan, numbered KM9910, deposited in the Land Registry.

*Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking*

The proposed works include:—

- (i) Modification of sections of the existing seawall for the construction of waterfront promenade along the Kai Tak Approach Channel.
- (ii) Erection of a temporary works area at the To Kwa Wan Typhoon Shelter for the reconstruction of a section of the existing seawall for the construction of a seawater intake point.

#### Personal Information Collection Statement

Any information, including the personal data, submitted to the Director of Lands in connection with any written claims served under section 12(1) of the Foreshore and Sea-bed (Reclamations) Ordinance (Chapter 127) will be used for the processing of the claims and other related purposes. The provision of the information, including the personal data, as required under section 12(1) of the Foreshore and Sea-bed (Reclamations) Ordinance (Chapter 127) is obligatory. If such information, including the personal data, as required under section 12(1) of the Foreshore and Sea-bed (Reclamations) Ordinance (Chapter 127) is not provided as requested, the claims may be rejected. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other organizations or agencies which are required to handle the claims and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us.
