

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 1033EM18T, Triennial Term Contract for Building Services Fitting-out, Replacement and Improvement Works for Health Sector Venues in Hong Kong East Region and Outlying Islands**. The scope of the Works includes fitting-out, replacement of, alterations, additions and improvement to building services installations and associated builder's works for the health sector venues in the Hong Kong East Region and Outlying Islands.
