(Notice under section 23)**

**HONG KONG SECTION OF
GUANGZHOU-SHENZHEN-HONG KONG EXPRESS RAIL LINK**

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF SECTIONS OF LIN CHEUNG ROAD AND
WUI CHEUNG ROAD, AND A SLIP ROAD FROM LIN CHEUNG ROAD TO
CROSS-BORDER COACH TERMINUS AT MTR KOWLOON STATION**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 9 March 2018 (the ‘Order’), authorized:–

- (I) the temporary closure of the carriageway widths of the section of Lin Cheung Road between Jordan Road and Austin Road West, as delineated and shown in pink on the Plans numbered XRL/G44/0022/3 and XRL/G45/0022/3;
- (II) the temporary closure of the slip road from Lin Cheung Road to Cross-Border Coach Terminus at MTR Kowloon Station, as delineated and shown in yellow on the Plan numbered XRL/G45/0022/3;
- (III) the temporary partial closure of the section of Lin Cheung Road between its junction with Jordan Road and a point about 380 metres north of the junction, as delineated and shown in blue on the Plan numbered XRL/G44/0022/3;
- (IV) the temporary partial closure of the footpath widths of the section of Lin Cheung Road between Jordan Road and Austin Road West, as delineated and shown in green on the Plans numbered XRL/G44/0022/3 and XRL/G45/0022/3; and
- (V) the temporary partial closure of the section of Wui Cheung Road between Canton Road and Wui Man Road, as delineated and shown in red on the Plan numbered XRL/G45/0022/3,

during the period from 1 April to 30 September 2018 for the purposes of or incidental to the railway scheme of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered XRL/G44/0022/3 and XRL/G45/0022/3 (the ‘Plans’) may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:–

A copy of this notice will be affixed on or near the roads affected by the Order on 23 March 2018.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing so as to reach the Secretary for Transport and Housing before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order. Claims can be submitted via one of the following means:–

- (1) by post or by hand to the Transport and Housing Bureau's Drop-in Box No. 6 located at the 2nd Floor Entrance, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong. The box is available for use between 8:00 a.m. and 7:00 p.m. from Monday to Friday (except public holidays);

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

<i>The roads to be affected</i>	<i>Description of the works and the manner in which the roads will be affected</i>
(a) The carriageway widths of the section of Lin Cheung Road between Jordan Road and Austin Road West, as delineated and shown in pink on the Plans numbered XRL/G44/0022/3 and XRL/G45/0022/3.	The carriageway widths will be temporarily closed to facilitate the construction of the terminus, the approach tunnel to the terminus and the underpass of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link.
(b) The slip road from Lin Cheung Road to Cross-Border Coach Terminus at MTR Kowloon Station, as delineated and shown in yellow on the Plan numbered XRL/G45/0022/3.	The carriageway widths will be temporarily closed to facilitate the construction of the underpass of Lin Cheung Road and the pedestrian subway connecting the terminus of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link and MTR Kowloon Station, and reinstatement works.
(c) The section of Lin Cheung Road between its junction with Jordan Road and a point about 380 metres north of the junction, as delineated and shown in blue on the Plan numbered XRL/G44/0022/3.	Parts of the carriageway and all of the footpath widths will be temporarily closed to facilitate the reinstatement works.
(d) The footpath widths of the section of Lin Cheung Road between Jordan Road and Austin Road West, as delineated and shown in green on the Plans numbered XRL/G44/0022/3 and XRL/G45/0022/3.	Parts of the footpath widths will be temporarily closed to facilitate the utility diversion and the construction of the underpass of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link, and reinstatement works.
(e) The section of Wui Cheung Road between Canton Road and Wui Man Road, as delineated and shown in red on the Plan numbered XRL/G45/0022/3.	Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the terminus of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link and its connection with the pedestrian subway at MTR Austin Station, and reinstatement works.
