TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways and footpaths within the limit of works area as shown on Plan No. CE58/GAZ/HF154/0001 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 4413 published on 1 August 2014 and 8 August 2014. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 2 April 2018 to 1 April 2019, all public or private rights in, upon, under or over the sections of the existing carriageways and footpaths to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of a lift at the existing footbridge no. HF154 across Gloucester Road and Percival Street near Sino Plaza, the construction of an elevated platform to connect the proposed lift with the existing footbridge, the construction of a staircase to connect the proposed elevated platform with the existing footpath and other ancillary works.
