TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close permanently a section of the existing footpath; and temporarily sections of the existing carriageway and footpath along Hing Wah Street West within the limit of works area as shown on Plan No. HPD/RD/ GZ001 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 5166 published on 17 July 2015 and 24 July 2015. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that as from 24 March 2018, all public or private rights in, upon, under or over the section of the existing footpath to be permanently closed, shall be extinguished; and from 24 March 2018 to 23 September 2018, all public or private rights in, upon, under or over the sections of the existing carriageway and footpath along Hing Wah Street West to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve construction of a single two-lane carriageway with associated footpaths, refuge islands, lay-by and vehicular ingresses and egresses to the east of Hing Wah Street West and other ancillary works.
