- . It has been brought to my attention that the following building works have been carried out in or at the above premises:
  - (i) Swing outward metal gate was installed at the unit entrance;
     (ii) An opening formed and swing outward metal gate erected at the partition wall leading to the staircase;
  - (iii) Removal of approved railing on balcony facing Silver Bay Garden;
  - (iv) Railing erected on the approved canopy facing Silver Bay Garden;

- (b) As a result of the building works at item (ii) above, Regulation 90 of the Building (Construction) Regulations, which requires the building to be designed and constructed so as to inhibit or provide adequate resistance to the spread of fire and smoke; and to maintain stability of the building in case of fire, has been contravened.
- (c) The building works at items (iii) to (v) above has been carried out without having first obtained from me the approval of building plans and consent for the commencement of such building works required by section 14 of the Buildings Ordinance
- 3. In exercise of the powers vested in me under section 24(1) of the Buildings Ordinance, I hereby order you to :-
  - (a) demolish the said building works described unde items (i), (ii), (iv) to (v) above; and
  - (b) reinstate the parts of the building so affected by the building works under items (i) to (v) above in accordance with the plans approved by the Building Authority/ minor works completion record submitted to the Building Authority.
  - (c) alter the building works described under items (i) to (ii) above to such a condition to put an end to the contraventions stated in paragraph 2(a) and 2(b) above.

Adequate precautionary measures to ensure public safety should be provided prior to and during the course of works.

4. You are required to commence the works ordered by me in paragraph 3 above within 30 days and complete such works within 60 days of the date of this order, all to the satisfaction of the Building Authority.


