1. It has been brought to my attention that the following building works have been carried out in or at the above premises:

- (i) A railing erected on top of approved canopy facing Silver Bay Garden;
 - (ii) Removal of approved railing on balcony facing Silver Bay Garden;
 - (iii) Metal railings erected on and over the roof curb facing Clear Water Bay Road, Life Villa and Silver Bay Garden;
 - (iv) A structure erected on and over the roof;
 - (v) Removal part of approved slab on roof and a staircase erected for access from 2/F to R/F.
- (The location of the building works described above are shown by item numbers on the 2 annexed plans, for purpose of identification only.)

2. For the said building works:

- (a) The building works at items (i), (iii) to (v) above has been carried out without having first obtained from me the approval of building plans and consent for the commencement of such building works required by section 14 of the Buildings Ordinance.

3. In exercise of the powers vested in me under section 24(1) of the Buildings Ordinance, I hereby order you to :-

- (a) demolish the said building works described under items (i), (iii) to (v) above; and
- (b) reinstate the parts of the building so affected by the building works under items (i) to (v) above in accordance with the plans approved by the Building Authority/ minor works completion record submitted to the Building Authority.

Adequate precautionary measures to ensure public safety should be provided prior to and during the course of works.

4. You are required to commence the works ordered by me in paragraph 3 above within 30 days and complete such works within 60 days of the date of this order, all to the satisfaction of the Building Authority.

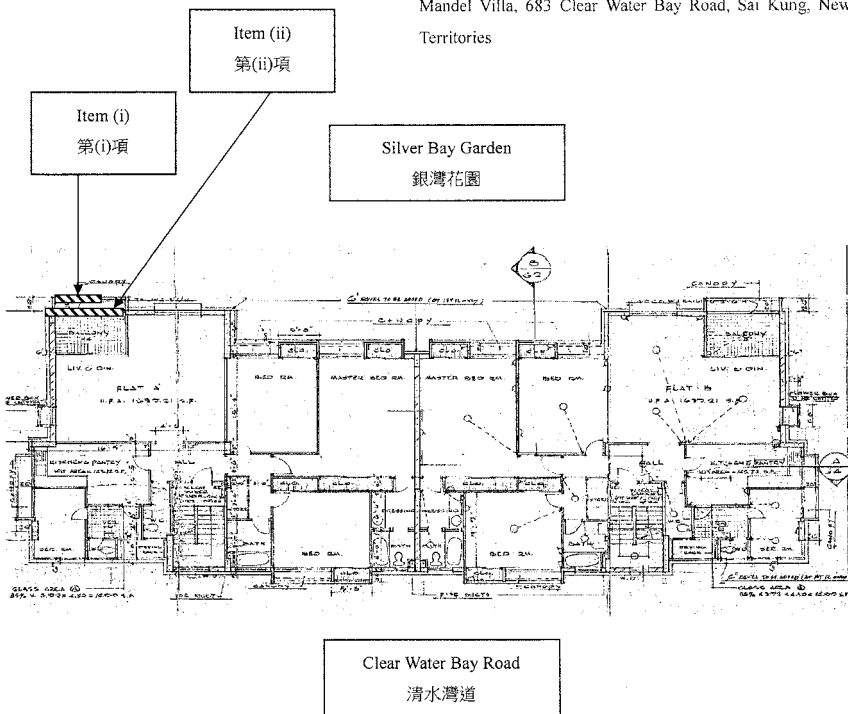

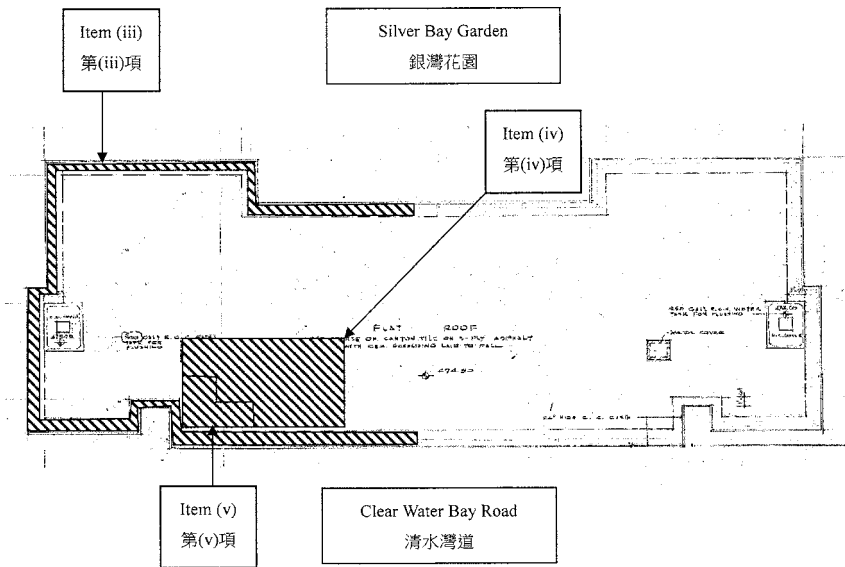
