Owner(s) of the premises at: **FLAT C ON 6TH FLOOR NO. 412 UN CHAU STREET KOWLOON** on (Lot Number) **N.K.I.L. 2814 s.E**

It has been brought to my attention that the following building works have been carried out in or at the above premises:

- (i) erection of brick wall with exhaust fan and window in the premises obstructing escape route to rear staircase; and
- (ii) removal of an approved fire resisting door at the entrance of the premises facing rear staircase.

2. For the said building works:

- (a) As a result of the building works at item (i) above, Regulation 41(1) of the Building (Planning) Regulations, which requires the building to be provided with such means of escape in case of emergency as required by the intended use of the building, has been contravened; and
- (b) As a result of the building works at item (ii) above, Regulation 90 of the Building (Construction) Regulations, which requires the building to be designed and constructed so as to inhibit or provide adequate resistance to the spread of fire and smoke; and to maintain stability of the building in case of fire, has been contravened.

3. In exercise of the powers vested in me under section 24(1) of the Buildings Ordinance, I hereby order you to :-

- (a) demolish the said building works described under item (i) above; and
- (b) reinstate the parts of the building so affected by the building works under items (i) & (ii) above in accordance with the plans approved by the Building Authority.

Adequate precautionary measures to ensure public safety should be provided prior to and during the course of works.

4. You are required to commence the works ordered by me in paragraph 3 above within 30 days and complete such works within 60 days of the date of this order, all to the satisfaction of the Building Authority.
