ROAD TRAFFIC (TRAFFIC CONTROL) REGULATIONS (Chapter 374)

RESTRICTED ZONES IN CHAI WAN

In exercise of the powers vested in me under regulation 14(1)(b) of the Road Traffic (Traffic Control) Regulations, Chapter 374, I hereby direct that with effect from 10.00 a.m. on 20 April 2018, the following road sections will be designated as restricted zones 24 hours daily:—

- (a) the section of Yee Shun Street from point about 15 metres north of its junction with Yee Shing Street to the same junction;
- (b) the section of Yee Shing Street from a point about 10 metres east of its junction with Yee Shun Street to the same junction:
- (c) the northern kerbside lane of Yee Shing Street from a point about 25 metres west of its junction with Yee Shun Sreet to the same junction;
- (d) the southern kerbside lane of Yee Shing Street from a point abour 30 metres west of its junction with Yee Shun Street to the same junction;
- (e) the western kerbside lane of Yee Shun Street from its junction with Yee Shing Street to a point about 20 metres south of the same junction;
- (f) the eastern kerbside lane of Yee Shun Street from a point about 15 metres north of its junction with Yee Fung Street to a point about 10 metres south of the same junction;
- (g) the northern kerbside lane of Yee Fung Street from its junction with Yee Shun Street to a point about 10 metres east of the same junction;
- (h) the southern kerbside lane of Yee Fung Street from its junction with Yee Shun Street to a point about 25 metres east of the same junction;
- (i) the western kerbside lane of Yee Shun Street from a point about 5 metres south of its junction with Yee Fung Street to a point about 10 metres south of the same junction;
- (j) the southern kerbside lane of Yee Fung Street from a point about 10 metres west of its junction with Kam Yuen Lane to a point about 10 metres east of the same junction;
- (k) the section of Kam Yuen Lane from its junction with Yee Fung Street to a point about 15 metres south of the same junction;
- (l) the section of Kam Yuen Lane from a point about 25 metres north of its junction with Chai Wan Road to the same junction;
- (m) the section of Yee Shun Street from a point about 25 metres north of its junction with Chai Wan Road to the same junction; and
- (n) the northern kerbside lane of Chai Wan Road from a point about 20 metres west of its junction with Yee Shun Street to a point about 15 metres east of its junction with Kam Yuen Lane.

Within the restricted zones, drivers of all motor vehicles, except franchised buses and those with permits issued by the Commissioner for Transport, will be prohibited from:—

- (a) picking up or setting down passengers; or
- (b) loading or unloading goods.

The extent of the restricted zones will be indicated by appropriate traffic signs and road markings.

At the same time, the existing restricted zones on the above road sections will be rescinded.
