

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. DC/2018/04—Lei Yue Mun Village Sewerage (Public Works Programme Item No. 4398DS)**. The works comprise the construction of public sewerage system in Lei Yue Mun Village and the upgrading of the existing Sam Ka Tsuen Pumping Chamber and sewers at Lei Yue Mun Praya Road and Lei Yue Mun Path. The works are scheduled to commence in August 2018 for completion in August 2022.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Logistics Department Tender Box situated on the Ground Floor of North Point Government Offices, 333 Java Road, North Point, Hong Kong, before 12.00 noon on Friday, 1 June 2018. Late tenders will not be accepted. If a black rainstorm warning signal or tropical cyclone signal No. 8 or above is in effect at any time between 9.00 a.m. and 12.00 noon on Friday, 1 June 2018, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 is lowered. An announcement of change will be made through the radio.
