TAKE NOTICE that under powers delegated by the Chief Executive of the Hong Kong Special Administrative Region, the Deputy Director/Specialist, Lands Department has made an order under section 13(1) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) directing that all that portion of the land known and registered in the Land Registry as The Remaining Portion of New Kowloon Inland Lot No. 4421 and The Extension Thereto (hereinafter referred to as 'portion of land') as shown coloured orange hatched black on Plan No. KM9748 annexed to the said order, which portion of land was described in the scheme referred to in Government Notice No. 3054 published on 12 May 2017 and 19 May 2017 shall be resumed.

Any person entitled to compensation under the Ordinance may serve upon the Secretary for Transport and Housing a written claim, which can be submitted *via* one of the following means, before the expiration of one year from the date of resumption—
