

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

(Notice under section 8(2))

PWP ITEM NO. 7786CL
TUNG CHUNG NEW TOWN EXTENSION
(WIDENING OF TUNG CHUNG ROAD NORTH)

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plan No. RD/GZ004 ('the Plan') and described in the scheme annexed thereto, which the Plan and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) widening of existing Tung Chung Road North to a single two-lane carriageway;
- (ii) construction of carriageways with associated footpaths, cycle tracks, cycle parking place, amenity areas, run-ins/run-outs and pedestrian crossings;
- (iii) permanent closure and conversion of sections of the existing carriageways into footpaths, cycle tracks, amenity area and slopes;
- (iv) permanent closure and conversion of sections of the existing footpaths into carriageways, cycle tracks, amenity areas and slope;
- (v) permanent closure and conversion of sections of the existing amenity areas into footpath and slopes;
- (vi) permanent closure and conversion of sections of the existing staircase into footpath and slopes;
- (vii) permanent closure and demolition of sections of the existing carriageways, footpath and amenity area;
- (viii) temporary closure and reconstruction of sections of the existing carriageways, footpaths and staircase;
- (ix) temporary closure of sections of the existing carriageways, amenity area and staircase; and
- (x) ancillary works including site formation, landscaping, drainage, sewerage, water, street lighting and utilities works, construction of staircase, retaining walls and slopes, and installation of street furniture and traffic aids.

The lots to be resumed as shown on Resumption Plan No. ISM2830a ('the Resumption Plan') annexed to the scheme are listed below:—

The objector should describe his interest and the manner in which he alleges that he will be affected by the works or the use in his notice of objection. Objectors are requested to provide contact details to facilitate communication. A notice of objection should be delivered to the Secretary for Transport and Housing not later than 24th day of July 2018.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Secretary for Transport and Housing in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is voluntary. However, it may not be possible to process the objections/comments if such information, including the personal data, is not sufficiently provided. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us. Request for access to or correction of the personal data should be made in writing to the Personal Data Privacy Officer of the Transport and Housing Bureau (Transport Branch) at 20th Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong.
