

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

(Notice under section 8(2))

SITE FORMATION AND INFRASTRUCTURE WORKS FOR
PUBLIC HOUSING DEVELOPMENTS AT POK FU LAM SOUTH

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plan No. GZ/001 ('the Plan') and described in the scheme annexed thereto, which the Plan and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) improvement works at the junction of Pok Fu Lam Road and Victoria Road, including widening of sections of Pok Fu Lam Road and Victoria Road;
- (ii) improvement works at a section of Victoria Road, including realignment of kerb line and relocation of central median/traffic island;
- (iii) relocation of the existing lay-bys along Victoria Road;
- (iv) improvement works at a section of Wah Lok Path, including realignment of kerb line;
- (v) modification of the alignment of a slip road from Wah Fu Road to Shek Pai Wan Road;
- (vi) modification of the existing lay-bys at Shek Pai Wan Road;
- (vii) widening of sections of the existing footpaths along Shek Pai Wan Road;
- (viii) construction of single two-lane carriageways with associated footpaths, covered footpaths, lay-bys, central medians/traffic islands, run-ins/run-outs and traffic light controlled pedestrian crossings connecting Kai Lung Wan North Site with the junction of Victoria Road and Pok Fu Lam Road. A section of the carriageway is in elevated form with associated elevated covered footpaths and elevated lay-bys;
- (ix) construction of carriageway, run-ins/run-outs, covered footpath and footpaths;
- (x) construction of footbridges and lift towers with associated staircases as well as traffic light controlled pedestrian crossing at Shek Pai Wan Road;
- (xi) permanent closure and conversion of sections of the existing carriageways into covered footpath and central medians/traffic islands;
- (xii) permanent closure and conversion of sections of the existing footpaths into carriageways, covered footpath, lay-bys and central median/traffic island;
- (xiii) permanent closure and conversion of sections of the existing bus terminus into footpath and lay-by along Wah King Street;
- (xiv) permanent closure and conversion of sections of the existing lay-bys into footpaths;
- (xv) permanent closure and conversion of sections of the existing central medians/traffic islands into carriageways;
- (xvi) permanent closure and conversion of the existing zebra crossings at Wah Fu Road into traffic light controlled pedestrian crossings;
- (xvii) permanent closure and demolition of sections of the existing footpaths and bus terminus;
- (xviii) demolition and conversion of sections of existing slopes into carriageways, footpaths, covered footpath, lift towers with associated staircases, central medians/traffic islands and lay-bys;
- (xix) temporary closure and reconstruction of sections of the existing footpaths, including the section at the north-east and north-west sides of World Fair Court, and lay-bys;
- (xx) temporary closure of sections of the existing carriageways, footpaths, lay-bys and central medians/traffic islands within the limit of works area; and
- (xxi) ancillary works including site formation, geotechnical, landscaping, water, drainage, sewerage, utilities, lighting and electrical and mechanical works, as well as construction of retaining walls and slopes.

Any person who wishes to object to the works or the use, or both, is required to address to the Secretary for Transport and Housing an objection in writing, which can be submitted via one of the following means:—

The objector should describe his interest and the manner in which he alleges that he will be affected by the works or the use in his notice of objection. Objectors are requested to provide contact details to facilitate communication. A notice of objection should be delivered to the Secretary for Transport and Housing not later than the 20th day of November 2018.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Secretary for Transport and Housing in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is voluntary. However, it may not be possible to process the objections/comments if such information, including the personal data, is not sufficiently provided. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us.
