

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 1960EM18T, Triennial Term Contract for Building Services Fitting-out, Replacement and Improvement Works for Hospital Authority Building and Kowloon Hospital and Nearby Health Services Venues**. The scope of the works includes building services fitting-out works, replacement, alterations and additions and improvement works for Hospital Authority Building and Kowloon Hospital and nearby Health Services Venues. The contract is scheduled to commence in February 2019 for expiration in January 2022.
