

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 1004EM18T, Triennial Term Contract for Maintenance of Speed Enforcement Camera System (Phase II) for Hong Kong Police Force**. The scope of the works includes comprehensive maintenance and repair of Speed Enforcement Camera System (Phase II) for Hong Kong Police Force. The contract is scheduled to commence in March 2019 for expiration in February 2022.

Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
