

It is hereby notified that sealed tenders in triplicate are invited for the **Provision of Wi-Fi Services for Government Bureaux and Departments (Tender Reference: GCIO90526301)**. This tender will be concluded as contracts for service for a period of 48 months.

In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. (Hong Kong time) and 12.00 noon (Hong Kong time) on the tender closing date, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
