It is hereby notified that sealed tenders are invited for Contract No. TD 93/2018—Installation of Additional Traffic Detectors, Speed Map Panel and Journey Time Indication Systems. The contract comprises three parts:—

- design, supply, delivery, installation, testing and commissioning of about 660 traffic detectors, new journey time indicators at 19 locations, 1 set of enhanced speed map panel, and associated power supply system, data communication system, computer server, and civil, structural, electrical and electronic works;

- (3) 6-year operation and maintenance services of the completed systems.

The contract is scheduled to commence in March 2019 and will take about 104 months to complete.

Open tendering is adopted. All interested contractors who meet the following requirement are invited to tender:----

The tenderer, or the major shareholder or lead participant in case of a joint venture tenderer, has completed at least one construction contract involving design, supply and installation of either Traffic Detector System (TDS) or Traffic Control and Surveillance System (TCSS) at roads, tunnels or viaducts, with awarded values of the TDS or TCSS not less than HK\$25 million, in or outside Hong Kong, within the past 15 years (counting back from and including the original date set for the close of tender).

The detailed requirements on the tenderer's qualification are stipulated in the tender documents.

This tender is covered by the Agreement on Government Procurement of the World Trade Organization and will not involve electronic auction. This notice also serves as a summary notice required under the Agreement on Government Procurement of the World Trade Organization.

A charge will be levied for delivery of tender documents where the delivery of tender documents is requested by a tenderer. A written request must be made.
