

It is hereby notified that sealed tenders are invited for the contracts for **procurement cum management, operation and maintenance of new generation of parking meter system for the Transport Department (Tender Reference: TD 111/2018)**. The duration of the contract shall be eleven years commencing on a date the Government of the Hong Kong Special Administrative Region shall specify by notice.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated at the Lobby of the Public Entrance on the Ground Floor of East Wing of Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong before 12.00 noon on Friday, 21 December 2018. Late tenders or tenders not deposited in the Government Secretariat Tender Box will not be accepted. If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is hoisted at any time between 9.00 a.m. and 12.00 noon on Friday, 21 December 2018, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 is lowered. In case of blockage of the public access to the location of the Government Secretariat Tender Box at any time between 9.00 a.m. and 12.00 noon on 21 December 2018, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Open tendering is adopted. All interested contractors/suppliers/service providers are invited to tender.

This tender is covered by the Agreement on Government Procurement of the World Trade Organization and will not involve electronic auction. This notice also serves as a summary notice required under the Agreement on Government Procurement of the World Trade Organization.

The Government of the Hong Kong Special Administrative Region does not bind itself to accept the lowest tender or any tender, and reserves the right to negotiate with any tenderer about the terms of the offer.
