Notice is hereby given that the Director of Environmental Protection proposes to amend the sewerage works originally described in the scheme and the Plans Nos. 60022486/V/HWYA1 and 60022486/V/HWYA2 and Resumption Plan No. TPM5769 (the 'Plans') referred to in G.N. 3170 published under section 8(2) of the Roads (Works, Use and Compensation) Ordinance as applied by section 26 of the Water Pollution Control (Sewerage) Regulation on 19 May 2017 and 26 May 2017 and rectified by Corrigendum in Government Notice No. 4044 published on 16 June 2017 and 23 June 2017.
