

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 1310EM18T, Biennial Term Contract for the Maintenance and Improvement of Electrical and Mechanical Installations for Hospitals and Clinics in New Territories East Region**. The scope of the works includes maintenance and improvement of Electrical and Mechanical installations for hospitals and clinics in New Territories East Region. The Contract is scheduled to commence in March 2019 for expiry in February 2021.
