The general nature of the proposed works is as follows:----

- (i) construction of about 400 metres of gravity sewers and associated manholes within the limit of works area;
- (ii) demolition of about 20 metres of gravity sewers and associated manholes within the limit of works area; and
- (iii) ancillary works including reinstatement of carriageways, footpaths and central reserves/ refuge islands or parts thereof.
