

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 1292EM18T, Quadrennial Term Contract for Maintenance of Water-Side System of Heating, Ventilation and Air-conditioning Installations for Hong Kong Boundary Crossing Facilities (HKBCF) at Hong Kong Zhuhai Macao Bridge**. The scope of the works includes provision of maintenance services, and carrying out of alteration, addition, replacement and improvement works of the water-side system of heating, ventilation and air-conditioning installations for Hong Kong Boundary Crossing Facilities (HKBCF) at Hong Kong Zhuhai Macao Bridge. The contract is scheduled to commence in April 2019 for expiry in March 2023.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board and placed in the Public Works Tender Box situated in Room 4128f, 41st Floor, Queensway Government Offices, 66 Queensway, Hong Kong, before 12.00 noon on Friday, 4 January 2019. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted.
