

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

CREATION OF EASEMENTS AND OTHER PERMANENT RIGHTS FOR

 KWUN TONG TOWN CENTRE REDEVELOPMENT—
 PROVISION OF GRADE-SEPARATED PEDESTRIAN LINKAGES—
 FOOTBRIDGE ACROSS HIP WO STREET
 NEAR THE JUNCTION OF HIP WO STREET/MUT WAH STREET

TAKE NOTICE that under powers delegated by the Chief Executive of the Hong Kong Special Administrative Region, the Deputy Director/Specialist, Lands Department has made an order under section 15(1) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) (hereinafter referred to as 'the Ordinance') directing that easements and other permanent rights be created in or over two portions of the land known and registered in the Land Registry as The Remaining Portion of New Kowloon Inland Lot No. 6499 (the said portions are hereinafter collectively referred to as 'the said portions of land') at such levels and locations as indicated and shown coloured purple and purple stippled black on Plan No. KM9371 annexed to the said order, which the said portions of land were described in the scheme referred to in Government Notice No. 2208 published on 22 April 2016 and 29 April 2016 (hereinafter referred to as 'the said scheme'), in favour of the Government of the Hong Kong Special Administrative Region for the purposes of or incidental to the works or the use described in the said scheme.

The Deputy Director/Specialist, Lands Department has under section 15(3) of the Ordinance further directed that subject to the serving of any notice required to be given under section 15(5) of the Ordinance, the Government, its contractors, employees, servants, agents, licensees and any other persons authorized or permitted by the Government shall be authorized to enter upon the said portions of land for the purposes of carrying out any operations or installing, maintaining or removing any structures or apparatus in connection with the said scheme.

This notice was affixed on or near the said portions of land on 27 December 2018.

The Deputy Director/Specialist, Lands Department has under section 15(2) of the Ordinance specified a period of notice of THREE MONTHS from the date upon which this notice was affixed on or near the said portions of land and it is hereby declared upon expiry of that period, the aforesaid easements and other permanent rights shall by virtue of section 15(4) of the Ordinance be created in favour of the Government of the Hong Kong Special Administrative Region for the purposes of or incidental to the works or use described in the said scheme.

Any person owning a compensatable interest under the Ordinance may serve upon the Secretary for Transport and Housing a written claim, which can be submitted *via* one of the following means, before the expiration of one year from the date on which the aforesaid easements and other permanent rights are created:—
