

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 2580EM18T, Triennial Term Contract for Maintenance of General Electronic Systems and Equipment for Government Facilities in West Kowloon Station**. The scope of the works includes provision of maintenance services of general electronic systems and equipment for the government facilities in West Kowloon Station of the Guangzhou-Shenzhen-Hong Kong Express Rail Link. The contract is scheduled to commence in July 2019 for expiry in June 2022.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board and placed in the Public Works Tender Box situated in Room 4128f, 41st Floor, Queensway Government Offices, 66 Queensway, Hong Kong, before 12.00 noon on Friday, 8 March 2019. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted.
