(Amendment to Plans and Scheme under section 7)

Ordinance as applied by section 26 of the Water Pollution
Control (Sewerage) Regulation)

Notice is hereby given that the Director of Environmental Protection proposes to amend the sewerage works originally described in the scheme and Plan No. 60027687/GAZ/9101A and Resumption Plan No. ISM2282 ('the Plans') referred to in G.N. 7244 published under section 8(2) of the Roads (Works, Use and Compensation) Ordinance as applied by section 26 of the Water Pollution Control (Sewerage) Regulation on 19 December 2014 and 24 December 2014.

Take further notice that the Director of Environmental Protection proposes to execute the amendment sewerage works as shown on the Amendment Plan No. 60027687/GAZ/9101B and the Resumption Plan No. ISM2282d ('the Amendment Plans') and described in the amendment scheme annexed thereto, which the Amendment Plans and amendment scheme have been deposited in the Land Registry.

The general nature of the proposed amendments is as follows:—

- (i) revision of the project title as shown on the Amendment Plans;
- (ii) revision of the limit of works area as shown on the Amendment Plans;
- (iii) addition of newly proposed land resumption of Lot No. 208 (Portion) in D.D. 4, Mui Wo as shown on the Amendment Plans;
- (iv) deletion of proposed land resumption of Lots Nos. 285 (Portion), 286 (Portion), 290, 303 RP (Portion), 340 RP (Portion), 341 (Portion), 345 RP (Portion), 427 S.A (Portion), 438 (Portion), 440 (Portion), 444 (Portion), 447 (Portion), 450 RP (Portion), 453 (Portion), 473 (Portion), 475 (Portion), 476 RP (Portion) and 549 (Portion) all in D.D. 3, Mui Wo; Lots Nos. 269 RP (Portion), 279 (Portion), 281 (Portion), 290 (Portion), 293 (Portion), 296 (Portion), 309 (Portion), 310 (Portion), 312 (Portion), 313 (Portion) and 373 (Portion) all in D.D. 4, Mui Wo as shown on the Amendment Plans;
- (v) change in the area of proposed land resumption of Lot No. 306 RP (Portion) in D.D. 3, Mui Wo and Lot No. 204 RP (Portion) in D.D. 4, Mui Wo as shown on the Amendment Plans; and
- (vi) length of gravity sewers within the limit of works area is revised from about 2,900 metres to about 1,000 metres.

Objectors are required to provide contact details to the Director to facilitate communication.

Any information, including the personal data, submitted to the Director of Environmental Protection in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) as applied by section 26 of the Water Pollution Control (Sewerage) Regulation (Chapter 358, sub. leg. AL) is voluntary. However, it may not be possible to process the objections/comments if such information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) as applied by section 26 of the Water Pollution Control (Sewerage) Regulation (Chapter 358, sub. leg. AL) is not sufficiently provided. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters.
