(WIDENING OF TUNG CHUNG ROAD NORTH)

Amendments under section 7

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance'), the Permanent Secretary for Transport and Housing (Transport) proposes to amend the works and the use originally shown on Plan No. RD/GZ004 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 3764 published under section 8(2) of the Ordinance on 25 May 2018 and 1 June 2018. The proposed amendments are shown on Amendment Plans Nos. RD/GZ004A and RD/GZ004A/LEGEND ('the Amendment Plans') and described in the amendment scheme annexed thereto. The Amendment Plans and amendment scheme have been deposited in the Land Registry.

The general nature and extent of the proposed amendments are as follows:—

- (i) revision of limit of works area;
- (ii) modification of the alignments of carriageways, footpaths, cycle track, and the locations of cycle parking place, amenity areas, run-ins/run-outs, pedestrian crossings, retaining walls and slopes;
- (iii) permanent closure and conversion of sections of the existing carriageways into footpaths, cycle track and amenity areas;
- (iv) permanent closure and conversion of sections of the existing footpaths into carriageways and amenity areas;
- (v) permanent closure and conversion of sections of the existing amenity areas into footpath and cycle parking place;
- (vi) permanent closure and demolition of sections of the existing carriageways and footpaths;
- (vii) temporary closure and reconstruction of sections of the existing carriageways, footpaths and amenity area;
- (viii) deletion of sections of the originally proposed carriageways, footpaths, cycle tracks, amenity areas, retaining walls and slopes;
- (ix) deletion of the originally proposed cycle parking place, run-ins/run-outs and pedestrian crossings;
- (x) deletion of the originally proposed permanent closure and conversion of sections of the existing carriageways into footpaths, cycle tracks, amenity areas and slope;
- (xi) deletion of the originally proposed permanent closure and conversion of sections of the existing footpaths into carriageway, cycle tracks, amenity area and slope;
- (xii) deletion of the originally proposed permanent closure and conversion of sections of the existing amenity area into slope;
- (xiii) deletion of the originally proposed permanent closure and demolition of sections of the existing carriageways and footpath;
- (xiv) deletion of the originally proposed temporary closure and reconstruction of sections of the existing carriageways and footpaths;
- (xv) deletion of the originally proposed resumption of lots in respect of the following:—

(xvii) revision of resumption/clearance limit as shown on Resumption Plan No. ISM2830b ('the Resumption Plan') annexed hereto; and

(xviii) revision of ancillary works including site formation, landscaping, drainage, sewerage, water, street lighting and utilities works, construction of retaining walls, and installation of street furniture and traffic aids.

The objector should describe his interest and the manner in which he alleges that he will be affected by the proposed amendments in his notice of objection. Objectors are requested to provide contact details to facilitate communication. A notice of objection should be delivered to the Secretary for Transport and Housing not later than 17th day of June 2019.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Secretary for Transport and Housing in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is voluntary. However, it may not be possible to process the objections/comments if such information, including the personal data, is not sufficiently provided. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us.
