

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. SS H508—Construction of Station Square at Kai Tak (Phase 2) (Programme No. 467RO)**.

The works include the construction of Phase 2 of the Station Square at Kai Tak comprising a Tai Chi plaza, lawn bowling greens, children's play areas, fitness stations, cycling grounds, jogging track, pet gardens, leisure lawn, sheltered seating areas, soft landscaping, covered walkways and ancillary facilities including toilets, a bicycle rental kiosk, plant rooms and store rooms together with drainage and external works. The site area is approximately 78 000 square metres. The main contract is scheduled to commence in September 2019 and for completion in March 2022.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer), addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated in the lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong before 12.00 noon on Friday, 14 June 2019. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is in force at any time between 9.00 a.m. and 12.00 noon on Friday, 14 June 2019, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 has been replaced by a lower signal. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 14 June 2019, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Selective tendering is adopted. Confirmed contractors on the List of Approved Contractors for Public Works in Group C for Buildings Category or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being on the above-mentioned approved list/category/group who also meet the following qualifications and other conditions for participation stipulated in the tender documents are invited to tender:—

- (1) the tenderer or the lead participant/major shareholder in a joint venture tenderer is a confirmed contractor on the List of Approved Contractors for Public Works in Group C for Buildings Category; and
- (2) the tenderer or the participants/shareholders in a joint venture tenderer have completed at least one construction contract with an adjusted original contract sum of not less than HK\$500 million in Hong Kong or any places outside Hong Kong within the past 10 years counting from and including the original date set for the close of tender (i.e. between 15 June 2009 and 14 June 2019). Only such contracts with substantial completion date falling within the above stated period will be considered.

The detailed requirements on the tenderer's qualifications and those for joint ventures with participation of local and/or overseas contractors, if applicable, are stipulated in the tender documents.

Contractors not yet on the above-mentioned approved list/category/group may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category/group by 21 May 2019 to Chief Quantity Surveyor/3 of Architectural Services Department at 5th Floor, Main Block, APB Centre, No. 9 Sung Ping Street, Hung Hom, Kowloon, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date.
