I have, on inspection, found certain dilapidations/defects in the building at (address) Whole piece of land of No.25 Fuk Lo Tsun Road Kowloon on (Lot No.) N.K.I.L.2613.

2. In exercise of the powers vested in me by section 26A(1) of the Buildings Ordinance, I HEREBY ORDER you as owner to appoint an Authorized Person and, within a period expiring on <u>3 August 2019</u>, to carry out the following:-

For the interior common areas and exterior of the building

- (a) Investigate the extent and location of dilapidations/defects, including all loose and defective rendering, assess the effect of the dilapidations/defects on safety of the building or its elements and submit the report.
- (b) Submit proposals for remedial works to be carried out as regards the dilapidations/defects based on the findings of the investigation to the Building Authority for approval.

All works specified in this Order shall be carried out to such standard acceptable to the Building Authority and in compliance with the rules and regulations made under the Buildings Ordinance.

3. Section 46 of the Interpretation and General Clauses Ordinance (Cap. 1) provides, inter alia, that where any Ordinance confers power upon any person to make any order, such power shall include power to substitute another order for the one already made. Pursuant to that section, the Building Authority who is empowered under section 26A(1) of the Buildings Ordinance (Cap. 123) to make the previous order i.e. Order No. INVO00365/K/10/TE dated 25TH June 2010 is also empowered to make this order which substitutes the previous order.

1. Subject to the findings of the investigation as stipulated in this Order, you shall carry out any remedial works as required or approved by the Building Authority. Your attention is drawn to section 26A(3) of the Buildings Ordinance that the Building Authority may by order in writing require the carrying out of such remedial works as appropriate within a specified time. Under section 26A(4) of the Buildings Ordinance, all works shall be carried out to such standard acceptable to the Building Authority and in compliance with regulations. Please also note that under sections 26A(5) & (6) of the Buildings Ordinance, the Building Authority may in certain circumstances carry out or cause to be carried out the works or investigation specified in the Order in which case the cost thereof shall be recoverable from you or your successor in title as appropriate.

2. Should you wish to appeal against my Order, you may give notice of appeal to the Secretary to the Appeal Tribunal (Buildings) and notice should be received by the Secretary not later than 21 days after the date of this Order (Address : Rooms 1005-06, 10/F, Wing On Kowloon Centre, 345 Nathan Road, Kowloon, Hong Kong and the fax number is (852) 3579 4971).
