

It is hereby notified that sealed tenders in three (3) sets of hard copies and two (2) sets of soft copies are invited for **the Tender for Provision of Mobile Workplace Services and the Supply of Mobile Workplace Handheld Devices to Various Government Departments (Tender Reference: GCIO90585210)**. The contract will cover a period of thirty-six (36) months.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box at the Lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong before 1200 (Hong Kong time) on 14 June 2019 (Friday).

Tenders must be deposited in the tender box as specified in this tender notice ("Specified Tender Box") before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted. If a black rainstorm warning signal or tropical cyclone warning signal No.8 or above is hoisted at any time between 09.00 and 12.00 (Hong Kong time) on 14 June 2019, the tender closing time will be postponed to 12.00 (Hong Kong time) on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No.8 is lowered. In case of blockage of the public access to the location of the Specified Tender Box at any time between 09.00 and 12.00 (Hong Kong time) on 14 June 2019, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
