## PWP ITEM NO. 6164TB FOOTBRIDGE CONNECTING TSUEN WAN PLAZA, SKYLINE PLAZA AND ADJACENT LANDSCAPING AREA

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways, footpaths, central reserves/refuge islands, pedestrian crossings, lay-by and landscaping area within the limit of works area as shown on Plan No. HWDTW061A-GZ0006 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 8094 published on 23 October 2015 and 30 October 2015. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 20 May 2019 to 19 May 2020, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths, central reserves/refuge islands, pedestrian crossings, lay-by and landscaping area to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of a covered footbridge with associated lift and covered staircase across Yuen Tun Circuit and Hoi Shing Road and other ancillary works.
