

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 1085EM19T—Triennial Term Contract for the Maintenance and Repair of Burglar Alarm and Security Installation at Various General Engineering Venues in Hong Kong Region of the Government of the Hong Kong Special Administrative Region**. The Works include inspection, examination, testing, adjustment, fully comprehensive servicing and maintenance of burglar alarm and security installations at various venues in Hong Kong Region of the Government of the Hong Kong Special Administrative Region which are responsible by the General Engineering Services Division of Electrical and Mechanical Services Department. The contract is scheduled to commence on 1 October 2019 for expiry on 30 September 2022.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board and placed in the Public Works Tender Box situated in Room 4128f, 41st Floor, Queensway Government Offices, 66 Queensway, Hong Kong, before 12.00 noon on Friday, 21 June 2019. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted.

If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is in force at any time between 9.00 a.m. and 12.00 noon on Friday 21 June 2019, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 is lowered. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon, on Friday, 21 June 2019, the Government will announce extension of the tender closing time until further notice. - (A) The tenderer shall have completed maintenance and repair contracts for burglar alarm and security installations with a total aggregate contract value of not less than HK\$2.5 million within the 5-year period immediately preceding the tender closing date specified in the Letter of Invitation to Tender regardless of any subsequent extension. In the case of a joint venture, only the lead participant or major shareholder is required to meet this minimum experience requirement; and
- (B) The tenderer of the lead participant/major shareholder of the joint venture must be on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works under the category of Burglar Alarm and Security Installation.

Contractors not yet on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works under the category of Burglar Alarm and Security Installation may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by 7 June 2019 to Mr. WONG Man-chong, General Engineering Services Division, Electrical and Mechanical Services Department, 3 Kai Shing Street, Kowloon, Hong Kong, meet the qualifications and conditions
