

L.N. 71 of 2019

Solicitor Advocates (Higher Rights of Audience Certificates) Rules

(Made by the Council of The Law Society of Hong Kong under section 73(1)(de) of the Legal Practitioners Ordinance (Cap. 159) subject to the prior approval of the Chief Justice)

1. Commencement

These Rules come into operation on a day to be appointed by the President of The Law Society of Hong Kong by notice published in the Gazette.

2. Higher rights of audience certificates

- (1) A certificate issued under section 39P(1) of the Ordinance for the higher rights of audience—
 - (a) in respect of civil proceedings, must be in accordance with Form 1 in the Schedule;
 - (b) in respect of criminal proceedings, must be in accordance with Form 2 in the Schedule; or
 - (c) in respect of both civil and criminal proceedings, must be in accordance with Form 3 in the Schedule.
 - (2) A certificate issued under section 39P(4) of the Ordinance must be in accordance with Form 4 in the Schedule.
