Late tenders and tenders not deposited in the Specified Tender Box will not be accepted. In case a black rainstorm warning signal or tropical cyclone signal No. 8 or above is in force at any time between 9.00 a.m. and 12.00 noon on the tender closing date, the tender closing time will be postponed to 12.00 noon on the first working date after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone signal No. 8 is lowered. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on the tender closing date, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
