Notice is hereby given that the undertaking described in the Schedule below is proposed. Any person who considers that he has an interest, right or easement in or over the foreshore and sea-bed so described may, by notice in writing delivered to the Director of Lands, 20th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong before the expiration of two months from the date of this notice, object to the proposed undertaking. The notice of objection shall describe the interest, right or easement of the objector and the manner in which he alleges he will be affected.

## SCHEDULE

*Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking*

*Foreshore and sea-bed affected*

Approximately 3 200 square metres of foreshore and sea-bed situated at the northern end of the former Kai Tak Airport runway as delineated and shown edged red on a plan, numbered KM10170, deposited in the Land Registry.

Construction of a seawater outfall at the northern end of the former Kai Tak Airport runway to support the district cooling system at the Kai Tak Development. Modification of the existing seawall and associated dredging works will be involved.

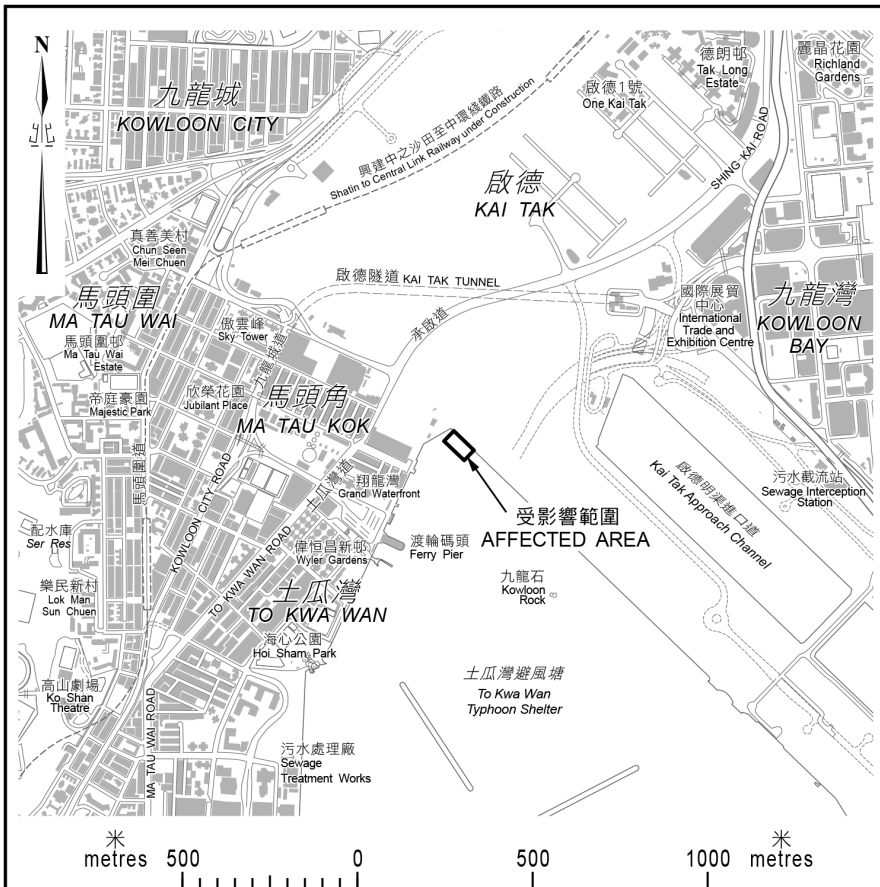
The area of foreshore and sea-bed affected is shown on the plan on the next page for identification purposes only. The area is more particularly shown on the plan numbered KM10170 above referred to.

Personal Information Collection Statement
