

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. SS H514—Construction of a 30-classroom Primary School at Shui Chuen O, Sha Tin (Programme No. 358EP)**.

The works include the construction of a 30-classroom primary school comprising a 7-storey classroom block, a 6-storey special room-cum-assembly hall block and associated facilities, together with geotechnical works to slope, drainage and external works. The construction floor area is about 11 000 square metres. The contract is scheduled to commence in September 2019 and for completion in September 2021.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer), addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated in the lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong before 12.00 noon on Friday, 12 July 2019. Tenders must be deposited in the tender box as specified in this tender notice ("Specified Tender Box") before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted.

If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is in force at any time between 9.00 a.m. and 12.00 noon on Friday, 12 July 2019, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 has been replaced by a lower signal.
