

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. DC/2018/07—Shek Wu Hui Effluent Polishing Plant—Main Works Stage 1—Civil Works for Sewage Treatment Facilities**. The works include civil works for sewage treatment facilities including inlet works no. 1, primary sedimentation tanks, bioreactors, pre-treatment screen chamber, membrane tanks and building no. 2 and associated buildings; and construction of other ancillary facilities including road works, pipeworks, etc. The works are scheduled to commence in October 2019 for completion in March 2024.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated at the lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong, before 12.00 noon on Friday, 26 July 2019. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted. If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is in effect at any time between 9.00 a.m. and 12.00 noon on Friday, 26 July 2019, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 is lowered. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 26 July 2019, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Selective tendering is adopted. Contractors or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being on the List of Approved Contractors for Public Works in Group C (confirmed) under Roads and Drainage Category on the tender closing date, who also meet the following qualifications and other conditions for participation stipulated in the tender documents are invited to tender:—

The tenderer has completed at least one (1) construction contract involving civil works for drainage works and/or sewerage works and/or water works and/or solid waste treatment works and/or sewage treatment works ('the relevant works') with the adjusted sum of value of the relevant works not less than HK\$350 million in or outside Hong Kong within the past ten (10) years counting from the original date set for the close of tender. The adjusted sum of value of the relevant works shall be the sum of value of the relevant works at the time of contract award being adjusted to current price level as stipulated in the tender documents. In the case of tender submitted by a joint venture tenderer, all participants or shareholders of the joint venture tenderer shall be collectively assessed as one entity as specified in the tender documents.

Contractors not yet on the List of Approved Contractors for Public Works in Group C (confirmed) under Roads and Drainage Category may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by Wednesday, 3 July 2019 to Chief Engineer/Sewerage Projects, Drainage Services Department at 44th Floor, Revenue Tower, 5 Gloucester Road, Wan Chai, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date.
