

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. SS H507—Construction of a 30-classroom Secondary School at Site KT2e, Development at Anderson Road, Kwun Tong (Programme No. 272ES)**.

The works include the construction of a secondary school comprising foundations, a classroom block and attached assembly hall (overall height 31.70 metres), together with drainage and external works. The construction floor area is 13 300 square metres. The main contract is scheduled to commence in October 2019 and for completion in November 2021.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer), addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated in the lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong before 12.00 noon on Friday, 12 July 2019. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is in force at any time between 9.00 a.m. and 12.00 noon on Friday, 12 July 2019, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 has been replaced by a lower signal.
