# NOTICE OF ORDER AUTHORIZING PERMANENT CLOSURE OF PARTS OF LOK SHAN ROAD PLAYGROUND, TO KWA WAN COMPLEX PLAYGROUND AND MA TAU WAI ROAD/TO KWA WAN ROAD GARDEN; AND TEMPORARY CLOSURE OF MA TAU WAI ROAD/TO KWA WAN ROAD AMENITY PLOT, AND PARTS OF MA TAU WAI ROAD/TO KWA WAN ROAD GARDEN

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 3 June 2019 (the 'Order'), authorized:-

- (I) the permanent closure of parts of Lok Shan Road Playground, To Kwa Wan Complex Playground and Ma Tau Wai Road/To Kwa Wan Road Garden, as delineated and shown in red, yellow and dark blue respectively on the Plan numbered SCL/G24/0002/5 with effect from 1 July 2019;
- (II) the temporary closure of Ma Tau Wai Road/To Kwa Wan Road Amenity Plot, and part of Ma Tau Wai Road/To Kwa Wan Road Garden, as delineated and shown in dark green and orange respectively on the Plan numbered SCL/G24/0002/5 during the period from 1 July to 31 October 2019; and
- (III) the temporary closure of parts of Ma Tau Wai Road/To Kwa Wan Road Garden, as delineated and shown in pink on the Plan numbered SCL/G24/0002/5 during the period from 1 July to 31 December 2019,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the areas of parts of Lok Shan Road Playground, To Kwa Wan Complex Playground, Ma Tau Wai Road/To Kwa Wan Road Garden and Ma Tau Wai Road/To Kwa Wan Road Amenity Plot to be affected and the manner in which they will be affected is given in the Schedule below.
