CENTRAL—WAN CHAI BYPASS AND ISLAND EASTERN CORRIDOR LINK

*Amendments under section 7*

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance'), the Permanent Secretary for Transport and Housing (Transport) proposes to further amend the scheme annexed to the Plans Nos. 92995/GAZ/1000 to 92995/GAZ/1008 ('the Plans'), and as amended by the amendment scheme annexed to Amendment Plans Nos. 92995/GAZ/1000A, 92995/GAZ/1005A, 92995/GAZ/1006A, 92995/GAZ/1007A and 92995/GAZ/1008A ('the Amendment Plans'). The Plans and scheme were referred to in G.N. 4767 published under section 8(2) of the Ordinance on 27 July 2007 and 3 August 2007. The Amendment Plans and amendment scheme were referred to in G.N. 8202 published under section 8(2) of the Ordinance on 5 December 2008 and 12 December 2008. The works and the use as described in the scheme as amended by the amendment scheme were authorized under section 11(2)(b) of the Ordinance and the notice of authorization was published in G.N. 3010 on 22 May 2009 and 29 May 2009.

The proposed further amendment is described in the second amendment scheme and shown on the Plan for Creation of Easements and Permanent Rights No. HKM10389 ('the Easements Plan') annexed thereto. The Easements Plan and second amendment scheme have been deposited in the Land Registry.

The proposed further amendment is to create additional area for the easements and permanent rights in a portion of land in The Remaining Portion of Marine Lot No. 293 and the Extension Thereto as follows:—

Creation of Easements and Permanent Rights

For the purposes of or incidental to the works or the use, the Permanent Secretary for Transport and Housing (Transport) proposes that powers under section 15 of the Ordinance may be exercised to create in, under or over a portion of land in The Remaining Portion of Marine Lot No. 293 and the Extension Thereto as shown on the Easements Plan annexed to the second amendment scheme and described hereunder in the table appended immediately under paragraph (vi) the following easements and permanent rights in favour of the Government:—

- (i) the right to construct, modify, extend, keep, retain, maintain and repair the proposed elevated carriageway with its associated noise barriers of Island Eastern Corridor (IEC) eastbound and the proposed road tunnel for the Central—Wan Chai Bypass;
- (ii) the right to manage, operate and use the proposed elevated carriageway with its associated noise barriers of IEC eastbound and the proposed road tunnel for the Central—Wan Chai Bypass;
- (iii) the right to enter and remain on the proposed elevated carriageway of IEC eastbound and the proposed road tunnel for the Central—Wan Chai Bypass;
- (iv) the right of exclusive occupation and use of the proposed elevated carriageway of IEC eastbound and the proposed road tunnel for the Central—Wan Chai Bypass and the right to allow members of the public to use and occupy the proposed elevated carriageway of IEC eastbound and the proposed road tunnel for the Central—Wan Chai Bypass;
- (v) the right to enter into, occupy or remain in, under or over the land for the purpose of carrying out maintenance and repair works for the proposed elevated carriageway with its associated noise barriers of IEC eastbound and the proposed road tunnel for the Central—Wan Chai Bypass; and
- (vi) the right to occupy and use the land and the right to permit and allow the contractors, employees, servants, agents, licensees and other authorized persons of the Government to occupy and use the land for any purposes incidental to any of the above purposes set out in paragraphs (i) to (v) above.

The objector should describe his interest and the manner in which he alleges that he will be affected by the proposed further amendment in his notice of objection.
