Pursuant to that section, the Building Authority who is empowered under section 24(1) of the Buildings Ordinance (Cap. 123) to make the previous order i.e. Order No. UBZ/U42/0444/01 dated 8 January 2003 is also empowered to make this order which substitutes the previous order.
