

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. ND/2019/05: Fanling North New Development Area, Phase 1: Fanling Bypass Eastern Section (Shung Him Tong to Kau Lung Hang) (Public Works Programme Item No. 747CL)**. The works mainly comprise:—

- (a) construction of an approximately 2 kilometres (km) long dual two-lane Fanling Bypass Eastern Section between Shung Him Tong and Kau Lung Hang mainly on viaducts with two long span overbridges across the existing East Rail Line;
- (b) realignment of part of the existing Tai Wo Service Road East, Tai Wo Service Road West and Fanling Highway;
- (c) construction of approximately 2.4 km long noise barriers, and relocation of approximately 400 metres long existing noise barriers along Fanling Highway;
- (d) alteration and addition works to the existing Ho Ka Yuen footbridge;
- (e) reprovisioning of a bus-bus interchange at Fanling Highway with a proposed public toilet and covered walkway; and
- (f) associated slope works, ground investigation, geotechnical instrumentation and monitoring, retaining wall, drainage works, waterworks, sewerage works, traffic control and surveillance system installation, electrical and mechanical works and landscaping works.

The works are scheduled to commence in December 2019 and will take about 54 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated at the Lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong, before 12.00 noon on Friday, 13 September 2019. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted.

If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is in effect at any time between 9.00 a.m. and 12.00 noon on Friday, 13 September 2019, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 is lowered. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 13 September 2019, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Selective tendering is adopted. Contractors on the List of Approved Contractors for Public Works in Group C (confirmed) under the Roads and Drainage Category or joint ventures with participation of local and/or overseas contractors with one of the members being on the List of Approved Contractors for Public Works in Group C (confirmed) under the Roads and Drainage Category who also meet the following qualifications and other conditions for participation stipulated in the tender documents are invited to tender:—

- (i) The tenderer, or the lead participant/major shareholder in case of a joint venture tenderer, has completed at least one roads and drainage works contract with an adjusted contract value of not less than HK\$1,000 million, in or outside Hong Kong, within the past 10 years counting from the original date set for the close of tender. The adjusted contract value shall be the awarded contract value being adjusted to current price level as stipulated in the tender documents;

- (ii) The tenderer, or the lead participant/major shareholder in case of a joint venture tenderer, has completed at least one construction contract involving construction of vehicular bridge works with a total bridge deck surface area between inner sides of the edge parapets not less than 10 000 square metres for each contract, in or outside Hong Kong, within the past 10 years counting from the original date set for the close of tender; and
- (iii) in the case of a joint venture tenderer:—
 - (1) at least one participant or shareholder (who may not be the lead participant or major shareholder) is a contractor in the List of Approved Contractors for Public Works in Group C (confirmed) under the Roads and Drainage Category; and
 - (2) the total percentage participation of participant(s) or shareholder(s) who may or may not be the lead participant or major shareholder and is/are contractor(s) included in the List of Approved Contractors for Public Works under the Roads and Drainage Category shall be at least 40%.

The detailed requirements on the tenderer's qualifications and those for joint ventures with participation of local and/or overseas contractors, if applicable, are stipulated in the tender documents.

Contractors not yet on the List of Approved Contractors for Public Works in Group C (confirmed) under the Roads and Drainage Category may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by 9 July 2019 to Chief Engineer/North 3, North Development Office, Civil Engineering and Development Department at Unit 1501, Level 15, Tower I, Metroplaza, 223 Hing Fong Road, Kwai Fong, New Territories, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date. Contractors will be liable to have their names removed from the approved list if they fail or refuse to implement an accepted tender.

This tender is covered by the Agreement on Government Procurement of the World Trade Organization and will not involve electronic auction. This notice also serves as a summary notice required under the Agreement on Government Procurement of the World Trade Organization.

A charge will be levied for delivery of tender documents where the delivery of tender documents is requested by a tenderer. A written request must be made.

The Government of the Hong Kong Special Administrative Region does not bind itself to accept any tender irrespective of whether the tender is the lowest bid or where the assessment of tenders is based on a marking scheme or formula approach, the tender has the highest overall score.
