

TOWN PLANNING ORDINANCE (Chapter 131)

AMENDMENTS TO THE APPROVED WONG NAI CHUNG
OUTLINE ZONING PLAN NO. S/H7/19

In the exercise of the power conferred by section 12(1)(b)(ii) of the Town Planning Ordinance (the Ordinance), the Chief Executive in Council (CE in C) on 31 October 2017 referred the approved Wong Nai Chung Outline Zoning Plan (OZP) No. S/H7/19 to the Town Planning Board (the Board) for amendment.

The Board has made amendments to the Plan. The amendments are set out in the Schedule of Amendments. The description of the areas affected by the amendments in the Schedule of Amendments is for general reference only. The exact locations of the areas affected by the amendments are more specifically shown on the draft Wong Nai Chung OZP No. S/H7/20.

The draft Wong Nai Chung OZP No. S/H7/20 showing the amendments is exhibited under section 5 of the Ordinance for public inspection for a period of two months from 24 May 2019 to 24 July 2019 during normal office hours at the following locations:—

- (i) the Secretariat of the Town Planning Board, 15th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong;
- (ii) the Planning Enquiry Counter, 17th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong;
- (iii) the Planning Enquiry Counter, 14th Floor, Sha Tin Government Offices, 1 Sheung Wo Che Road, Sha Tin, New Territories;
- (iv) the Hong Kong District Planning Office, 14th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong; and
- (v) the Wan Chai Home Affairs Enquiry Centre, Ground Floor, 2 O'Brien Road, Wan Chai, Hong Kong.

In accordance with section 6(1) of the Ordinance, any person may make representation to the Board in respect of the amendments. The representation should be made in writing to the Secretary, Town Planning Board, 15th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong not later than 24 July 2019.

In accordance with section 6(2) of the Ordinance, a representation shall indicate:—

- (a) the particular matter in any of the amendments to which the representation relates;
- (b) the nature of and reasons for the representation; and
- (c) the amendments (if any) proposed to the draft plan.

Any representation made to the Board will be available for public inspection under section 6(4) of the Ordinance until the CE in C has made a decision in respect of the draft plan in question under section 9.

Any person who intends to make representation is advised to read the revised Town Planning Board Guidelines No. 29B on 'Submission and Publication of Representations, Comments on Representations and Further Representations under the Town Planning Ordinance' (TPB PG-No. 29B) promulgated in November 2018 and taking effect in 2019. Submission of representation should comply with the requirements set out in TPB PG-No. 29B. The Guidelines and the submission form are available at locations (i) to (iii) above and the Board's website (<http://www.info.gov.hk/tpb/>).

Statement on Personal Data

The personal data submitted to the Board in any representation will be used by the Secretary of the Board and government departments for the following purposes:—

- (a) the verification of identity of the person making the representation (hereafter known as 'representer') and the authorized agent;
- (b) the processing of the representation which includes making available the name of the 'representer' for public inspection when making available the representation for public inspection; and
- (c) facilitating communication between the 'representer' and the Secretary of the Board/government departments.

MADE BY THE TOWN PLANNING BOARD
UNDER THE TOWN PLANNING ORDINANCE (Chapter 131)**

I. Amendments to Matters shown on the Plan

Item A — Rezoning of the northern and eastern part of the Caroline Hill Road (CHR) Site fronting Leighton Road from 'Other Specified Uses' annotated 'Sports and Recreation Club' ('OU (SRC)') and 'Government, Institution or Community' ('G/IC') to 'Commercial (2)' ('C (2)') with revision to the maximum building height from 2 storeys and 3 storeys to 135mPD.

Item B — Rezoning of the southern part of the CHR Site from 'G/IC' to 'G/IC (2)' with revision to the maximum building height from 3 storeys to 135mPD.

II. Amendments to the Notes of the Plan

- (a) Revision to the Remarks of the Notes for the 'C' zone to stipulate the restriction on gross floor area and the requirements regarding the provision of Government, institution or community facilities and a public open space for the 'C(2)' sub-zone.
- (b) Revision to the Remarks of the Notes for the 'G/IC' zone to stipulation the restriction on gross floor area for the 'G/IC(2)' sub-zone.
- (c) Deletion of 'Market' from Column 1 of the Notes for the 'Commercial' zone, and from Column 2 in the Notes for the 'Residential (Group B)' zone, and revision of 'Shop and Services' to 'Shop and Services (not elsewhere specified)' in Column 2 in the Notes for the 'Residential (Group A)' and 'G/IC' zones.
