

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 2603EM18T, Triennial Term Contract for the Comprehensive Maintenance and Repair of Escalator Installations at Various Premises of the Hospital Authority (SC18E)**. The scope of the Works includes maintenance and repair of Escalator installations in various premises of the Hospital Authority. The Works is scheduled to commence in September 2019 for expiry in August 2022.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board and placed in the Public Works Tender Box situated in Room 4128f, 41st Floor, Queensway Government Offices, 66 Queensway, Hong Kong, before 12.00 noon on Friday, 26 July 2019. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted.
