

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 2872EM18T, 28-Month Term Contract for Maintenance of Heating, Ventilation and Air-conditioning Installations for Health Sector Venues in Kowloon West Region**. The scope of Works includes maintenance of heating, ventilation and air-conditioning installations for health sector venues in Kowloon West Region. The Works is scheduled to commence in December 2019 for completion in March 2022.
